### Tender for Security AMC at NBSC Lucknow

Please refer to the pre-bid meeting held on 04 February 2019 @ 11 AM in NBSC on the above subject. In this connection, the following are the clarifications on the queries raised by the bidders, present in the meeting.

1		The last date for submission / receipt of tender(s) is <b>extended till 18<sup>th</sup> February 2019</b> till 1400 hrs. The tender box will be opened by the Tender / Local Purchase Committee in the presence of tenderers or their authorized representatives who wish to be present on the same day at 1600 hrs. in the office of NBSC.	
2	Page 30, Annexure VII - Undertaking	Whether the undertaking is to be given on the agency letter head or Stamp paper because in the NIT some undertakings are required to be submitted on Stamp paper and some on letter head?	The Integrity Pact (Annexure III) and the undertaking (Annexure VII) should be on Rs. 100/- Stamp Paper, while all other documents may be submitted on the letter head of the agency.
3	Page 5, Para 2.5	Lucknow not being a city of the magnitude of Metropolitans, it is difficult to have similar contracts at Lucknow by minimum of 3 parties.	Para is modified to read – Must have been awarded similar contracts at Lucknow by minimum of 2 parties but preferably 3 parties or more, of which at least one must be a Public Sector Bank or a Central Government Department with minimum of 45 guards deployed in one location. These contracts must have been awarded during the preceding three years. The agency having 3 or more such works in Lucknow will get weightage over others.
4	Page 11, Pt 9.1.3	The Price Bid may be submitted only in original. No duplicate copy is required.	
5		NBSC will determine a minimum workable % of service charge based on various parameters as given in the Annexure XI (Price Bid) of our tender document. This pre-determined % will be kept in a sealed envelope and dropped in the tender box. It will be opened in front of the vendors after opening the financial bids. NBSC shall reserve the right to accept only those Price Bids which are equal or greater than the pre-determined % of Service Charges.	

6	Vendors are advised to visit the campus and see the existing arrangements and read the full tender document before submitting the tender.
7	<p>Page 26, Annexure IV is amended to read –</p> <p>Scoring of <b>100 marks</b> will be based on Annual Turnover, Manpower on roll, experience of running security services, volume of work performed in preceding years, trained Sanitation/Hygiene Supervisory Staff on roll, ISO certification and other pre-qualification criterion prescribed in the Terms and Conditions of the contract (NBSC, Lucknow may fix the marks accordingly).</p> <p>The firm/agency which has secured <b>70 out of 100 marks</b> will be considered as technically qualified. The financial bids of all the technically qualified firms/agencies/bidders will be opened for financial evaluation. The date for opening pf Price Bid will be intimated to all the bidders who qualify in technical evaluation.</p> <p>The work will be awarded to the L-1 agency. In case the financial bid of more than one agency is same as L-1, then the work will be awarded to the agency which gets the maximum marks in Technical evaluation.</p>
8	<p>The following line is added to Para 2.3 of Page 5 –</p> <p>The participating vendors should compulsorily have an office (Registered / Branch) in Lucknow. A copy of the address proof of the agency may be submitted with the technical bid.</p>
