### <u>Eligibility:</u>

- **1.** <u>**Turn Over:**</u> Bidder shall have a minimum annual turnover of Rs 2 Lakh per year for the last three financial years (i.e. 2015-16, 2016-17 and 2017-18), duly supported by audited or CA certified statement of accounts.

- 4. - 6. Sealed RFQ application shall be deposited in the 'Quotation Box' kept in the Administrative Block, National Bank Staff College, Lucknow, within the stipulated time/date only.
- 7. Full name, postal address, email address and telephone number of the bidder shall be written on the bottom left hand corner of the sealed covers.
- 8. Corrections, if any, in the quotation shall be duly authenticated with full signature. In case of any difference between the figures and the wordings, the wordings will be taken as the correct one.
